## Minutes of the Meeting:

Adjourned Annual General Meeting 2016, started at the Institute Hall of IIEST, Shibpur on Sunday, 7th August 2016 with 62 members present either physically or via proxy forming the required quorum. 6 more members were present via Skype or Telephone. Since the President was physically absent as per Regulation of the Society, Vice President Aloke Ranjan Bhunia was requested to chair the meeting.

#### Agenda #1: Welcome address by the Chairperson

Vice President welcomed the present members of the house and thanked each of them for forming the required quorum. He briefly described about GAABESU and major recent



activities. Then he requested the Honorary Secretary to conduct the scheduled business of the Annual General Meeting.

# Agenda #2: To receive, consider and confirm the proceedings of the 8th Annual General Meeting held on 11th July 2015

With the permission of the Past Secretary, Honorary Secretary (2015-17) presented the proceedings of the previous Annual General Meeting to the house. The house confirmed it.

The house also approved the amendment of the MOA&R done through the SGM held on 4<sup>th</sup> April 2015 and suggested the Executive Committee to get the amendment formally approved from the Registrar of Firms, Societies and Non-Trading Corporations.

### Agenda #3: To ratify the admission of new Executive Committee members

The names of the current Executive Committee Members were presented by the Honorary Secretary, Partha Pratim Roy, to the house to ratify the admission of the new members. The list was accepted by the house.

# Agenda #4: To receive, consider and adopt the Annual Report of the Executive Committee for 2015-16

Honorary Secretary presented the Annual Report of the Executive Committee for 2015-16. The session was interactive and some members shared their opinion which were noted and responded. The report was accepted by the house.

#### Agenda #5: To receive, consider and adopt the Audited Accounts for the year 2015-16

Treasurer Somnath Sinha Roy placed the Account and Audit Report for the financial year 2015-16. Present members shared their opinion which were responded. The house accepted the Audited Accounts.

#### Agenda #6: To consider and approve the budget estimates for the year 2016-17

As requested by the Treasurer, the Honorary Secretary presented the budget estimate prepared by the Executive Committee for the year of 2016-17. Present members shared their opinion which were noted. The house approved the budget estimate.

#### Agenda #7: To appoint an Auditor and fix his/her remuneration for the year 2016-17

Since the previous auditor expressed his desire to discontinue, Honorary Secretary placed the recommendation of the Executive Committee to appoint, Arup Dasgupta & Associates (Firm Registration Number: 324617E) as new Auditor of the Association for the financial years 2016-17. The recommendation was unanimously accepted by the House.

#### Agenda #8: To announce new Logo of the Association

Executive Committee (2015-17) conducted an open competition of design the new Logo of the Global Alumni Association of Bengal Engineering and Science University, Shibpur. The logo was formally released on this occasion through the hand of Director of IIEST, Shibpur Prof. Ajoy



Kumar Ray, Past President Syama Prasad Datta, Past Working President Amitabha Datta, Past Secretary Pratik Dutta and other dignitaries.

The house adopted the new Logo of the Association.

Agenda #9: To consider Resolutions brought forward by the Executive Committee and individual members

Executive Committee and the members brought total eleven resolutions which were read out by the Secretary for consideration by the house:

#### **Resolution 01** – brought by the Executive Committee

Since the MOA&R amendment is due for formal approval, it was proposed that, "A person who is ex-student of Bengal Engineering College / Bengal Engineering College Deemed University / Bengal Engineering and Science University / Indian Institute of Engineering Science and Technology, Shibpur and who agrees in writing to be bound by Memorandum of Association, regulation and bye-laws (if and when framed and approved by the members and the Register of the Firm and Societies and Non-Trading Organization, West Bengal) and the Society shall be eligible for the life or annual membership."

This was accepted by the house.

#### **Resolution 02** – brought by Suman Nihar, L/014/ME/N0072

Suman Nihar proposed that, "Two-Third of the EC (Executive Committee) Members along with President, Secretary and Treasurer (as these office bearer posts are important to run the society smoothly by addressing different issues and meeting with its members) should be from in and around Kolkata and Howrah for the betterment of society with immediate effect."

The house discussed over this and accepted the requirement of local workforce and office bearer. However, no specific strength was agreed. This was recorded for consideration during future amendment.

### **Resolution 03** – brought by Suman Nihar, L/014/ME/N0072

Suman Nihar proposed that, "GAABESU must have a dedicated website which is owned by GAABESU and all income from this website should be deposited to GAABESU India bank account and must be audited and published for public review."

New website was already deliberated under agenda #4 and accepted by the house.

#### **Resolution 04** – brought by Ananta Deb Dutta, L/06/CE/D0044

Ananta Deb Dutta proposed that, "GAABESU Grants and Scholarships – Administration/ audit and interest of GAABESU: If such corpus created out of donation to GAABESU that should directly be controlled by GAABESU. A transparent position in terms of policy and administration of such scholarships / grants including criteria, provision, quantity, etc. should be displayed in the best interest of the Society."



This was accepted by the house.

#### Resolution 05 – brought by Ananta Deb Dutta, L/06/CE/D0044

Ananta Deb Dutta proposed that, "Amendment to the original MOA has not been approved by AGM, hence redundant whereas, EC5 is formed in terms of the Amendment. It is therefore essential for the EC/ Office-bearers to comply with the original MOA immediately to safeguard the Society from any penal action from the Registrar of Societies."

This was already deliberated under agenda #2 and accepted by the house. The house already suggested immediate action for formal approval of amendment.

Resolution 06 – brought by Kumar Bappaditya Salui, L/014/ME/S00424

Kumar Bappaditya Salui proposed that, "GAABESU annual and life membership fees can be periodically reviewed by the acting executive committee and revise as and when needed."

This was accepted by the house, which is in line of the proposed amendments.

#### Resolution 07 – brought by Kumar Bappaditya Salui, L/014/ME/S00424

Kumar Bappaditya Salui proposed that, "A person who is present faculty or spouse of exstudent of Bengal Engineering College/ Bengal Engineering College Deemed University/ Bengal Engineering and Science University/ Indian Institute of Engineering Science and Technology, Shibpur and who agrees in writing to be bound by Memorandum of Association, regulation and bye-laws (if and when framed and approved by the members and the Register of the Firm and Societies and Non-Trading Organization, West Bengal) and the Society shall be eligible for the life membership. However associate members will not have voting rights."

This was accepted by the house, which is in line of the proposed amendments.

#### Resolution 08 – brought by Kumar Bappaditya Salui, L/014/ME/S00424

Kumar Bappaditya Salui proposed that, "All amendments of this society is declared to be illegal and therefore GAABESU will strictly follow the original MoA which is registered with Government body from now onward till any amendment is approved by members as per MoA and registered with the government body."

This was already deliberated under agenda #2. The house already suggested immediate action for formal approval of amendment.

Resolution 09 – brought by Chirantan Chattopadhyaya, L/010/ME/C00149

Chirantan Chattopadhyaya proposed that, "A Library to be started under GAABESU"



This was well appreciated by the house. However, the house agreed to check the feasibility before doing so. In the meantime, it was agreed that interested alumni can donate books to Central Library of IIEST, Shibpur.

#### **Resolution 10** – brought by Syama Prasad Datta, L/05/CE/D0012

Syama Prasad Datta proposed that, "I feel we should help IIEST to have a decent surrounding around Guest House as the place is frequently visited by distinguished persons."

This was well appreciated by the house. However, Past Secretary informed the house that IIEST, Shibpur is in the verge of receiving a fund from Central Government, hence GAABESU shouldn't require to be get involved in any infrastructural project. This was in line of the Annual Report of the Concluding Annual General meeting of EC4, held on 2015. Hence, the house agreed not to get involved in this infrastructural project.

#### Resolution 11 – brought by Syama Prasad Datta, L/05/CE/D0012

Syama Prasad Datta proposed that, "I suggested providing a suitable pavement with concrete paver block for car parking by the side of the road near Guest House. I feel we can initiate a proposal from GAABESU."

This was well also appreciated by the house. However, in line of previous discussion, the house agreed not to get involved in this infrastructural project.

#### Agenda #10: To consider any other item(s) with permission of the chair

- Past EC Member, Asim Deb with his batchmates from the Class 1977 donated an amount in the GAABESU Emergency Fund through the hand of the Director, IIEST, Shibpur.
- The Director, IIEST, Shibpur in his brief address thanked Alumni and GAABESU for getting involved in various activities of the Institution.
- EC Member Chirantan Chattopadhyaya, insisted on some procedure to increase the membership of GAABESU.
- Past President Syama Prasad Datta mentioned that, "GAABESU since its inception has been trying to support as far as possible in development of our Alma Mater, providing benefits and facilities for the students. In the process various projects have been taken up which are either completed or ongoing. Being satisfied with our activities appropriate authority in the Government has given us registration under section 80G of IT Act. We call for donation after declaration of a project. I believe we can invite donations outlining our objectives. This will help in taking up projects immediately when it is necessary. I know there is no bar at present but there is a confusion which should be clarified and announced".
